- 3. The bidders must submit the Manufacturer Authorization Form(MAF) Letter along with their bid to make sure the supplied software bare genuine.
- 4. The Financial Proposal must also mention the support during warranty period.
- 5. All bids must be accompanied by a call deposit of two percent (2%) of total bid amount of each lot separately in favor of The Bank of Khyber.
- 6. The bids complete in all respects must be delivered to the HEAD IT DIVISION, THE BANK OF KHYBER, before 22-06-2015. The bids will be opened on 23-06-2015.
- 7. The Bank Of Khyber will not be responsible for any costs or expenses incurred by bidders in connection with the preparation or delivery of bids.
- 8. Bidders shall submit Bids, which comply with the Bidding Documents. Alternative Bids will not be considered.
- 9. Delivery of all items must be made within (4-6) weeks of issuance of purchase order.
