Bidders are required to submit its Proposal in accordance with the Mandatory Requirements as mentioned below. Failing to which the proposal will not be considered.

1	The bidder/firm must be well reputed and authorized dealer/distributor.	Authorized partner/dealer of the Manufacturer for the quoted equipment and must provide its certificate

2	The bidder should be registered with FBR and KPRA in company name.	The bidder should provide its FBR & KPRA registration certificate.
3	The bidder should have at-least 3 years' experience in the business. Bidder must have executed similar works agreements.	Valid documentary evidence must be submitted of similar scope of work.
4	The bidder should not have been blacklisted by any of the Provincial / Federal Government or organizations of the State / Federal Government in Pakistan. The bidder should not be in litigation with its customers/clients.	Affidavit / Undertaking on stamp papers to this effect should be submitted by the bidder duly attested by notary public.
6	Company/Firm Audited Balance Sheet.	Company should be audited by chartered accountant firm and copies should be attested by CEO of the company.
7	The bidder must be registered entity and must be having well placed organizational structure. It must be having Offices in major cities and should have appropriate technical manpower.	Certificate of incorporation/registration to be submitted along with list of Offices across Pakistan and list of technical staff.
8	Bidder shall provide warranty of the UPS	Confirmation of providing minimum warranty period of one year to be submitted.
9	Acceptance of Bid Document	Bidder must accept complete bid document with signed and company stamp.

GENERAL REQUIREMENTS/TERMS AND CONDITIONS

- Bid must be in computer written form, acceptance or rejection of hand written bid shall be sole discretion of the bank. There should not be errors and / or over-writings. Corrections if any should be made clearly and initiated with dates.
- Bids must be enclosed in a properly sealed envelope.
- Quoted online 3KVA/6KVA UPS should be well reputed brand.
- Quoted SNMP Card for UPS should be reputed brand.
- Supply / installation time should not exceed two working days from the date of placing of purchase order for settled areas, whereas, four working days for delivery of item in remote areas of the country.
- The supplier shall be responsible for the delivery/installation/commissioning of the UPS at the specified location/branch throughout Pakistan.
- The Bank of Khyber reserves the right to choose the specification/ models/ makes at its discretion. The bidder must submit all the relevant documents/broacher/information material regarding the guoted brand.
- Framework contract shall cover all offices/branches of the bank throughout Pakistan.
- Bids received late shall not be entertained.
- The Bank of Khyber will not be responsible for any costs or expenses incurred by bidders in connection with the preparation or delivery of bids.
- Quoted amount will remain valid during period of framework contract i.e. one year.
- The Bid shall remain valid for 90 days, after the date of opening the tender.
- All prices quoted in Pak rupees and must be inclusive of all applicable Taxes, such as GST, Income Tax, etc.
- No conditional bid will be acceptable.
- Rate should be quoted in words and figures.
- No negotiations and revised bids will be allowed.
