- Highest price bidder above the reserved price shall be considered successful for each vehicle among all participating bidders.
- Successful bidder liable to pay all applicable Government taxes on purchase of Vehicle at the time of payment.
- Rs. 100,000/- bid security (Call Deposit) shall be required for each vehicle separately. Combined bid security for more than one vehicle shall not be entertained and bid will be rejected.
